Sir/Madam,

This is with reference to the proposal submitted by BMS Institute of Technology and Management, P.B. No.6443, Avalahalli, Bangalore – 560064, Karnataka affiliated to Visvasvaraya technological University, Belagavi under the UGC Scheme for Autonomous Colleges.

As per the decision of the Standing Committee constituted by University Grants Commission, in its meeting held on 11.02.2021, the Competent Authority has decided to grant autonomous status to **BMS Institute of Technology and Management, P.B. No.6443, Avalahalli, Bangalore – 560064, Karnataka** affiliated to **Visvasvaraya Technological University, Belagavi** for a period of Ten (10) years from the session 2020-2021 to 2029-2030 as per provisions of Clause 3.13 and Clause 6.4 (i) of UGC Regulations dated 12.02.2018.

The University is requested to issue necessary notification/order regarding the grant of autonomous status to the college as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.ac.in. Non compliance of the requirements and conditions in the said Regulations shall attract action as per Clause -14 of the UGC Regulations – 2018. The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.

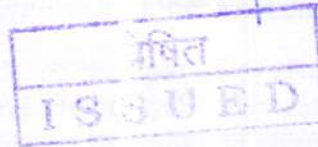



Pursuant to the Executive Council Resolution cited at ref (2) **BMS Institute of Technology and Management, Bengaluru** an affiliated college under VTU, Belagavi has been '**Conferred Fresh Autonomous Status**' based on the Eligibility Criteria mentioned in UGC Regulation for Autonomous Colleges- 2018 and in concurrence with the UGC letter for extension of autonomy status vide cited in ref(3) for a period of ten years starting from the academic year 2020-2021 to 2029-2030, subject to the following conditions.

You will be governed by the prevailing statutes and regular of the University applicable for Autonomous Institutes.

Conditions:

1. The College shall abide by the provisions of the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 and amended from time to time
2. The College shall strictly abide by the VTU Act, Statutes (VTU Statues on Autonomous Colleges Amended-2018, assented on 29-3-2021), VTU Guidelines for Implementation of Academic Autonomy, Rules and Regulations of the Visvesvaraya Technological University (VTU), Belagavi as when it is revised/amended from time to time.
3. The College shall get its programmes accredited by the National Board of Accreditation (NBA) and National Assessment and Accreditation Council (NAAC) as and when it is mandated by the UGC, AICTE and VTU.
4. The College shall send annual returns to the University every year by 31st March in the format prescribed in Guidelines for Implementation of Academic Autonomy.

5. The College shall send the list of admitted candidates to the University for Approval and generation of University Seat Numbers immediately after reconciliation against the University notification in this regard.
6. The College shall not permit any student to appear for the examination without the admission approval of University.
7. The College shall not permit any student to migrate from Non-Autonomous to Autonomous scheme within the college or from other Colleges/ University without prior approval of the VTU.
8. The College shall send the list of successful candidates approved in the Academic Council of the College for Conferment of Degrees or Certificates by the University within prescribed date(s).
9. The College shall collect the fees as per the Notifications issued by University and Government from time to time.
10. Any other notification issued by the University from time to time shall be followed.
11. The College shall remit the Student Registration and other fee to the University as notified in this regard from time to time.
12. The College has to obtain concurrence from Karnataka State Government.
13. The College needs to pay One Time Affiliation Fees and other applicable fees as prescribed by the University from time to time.
14. The College has to initiate steps to notify the Status of Autonomy for its Stakeholders with Intimation to the State Government & University.
15. The College shall pay any due/balance fee to the University immediately.
