

This is regarding Compliance Report submitted by BMS Institute of Technology and Management, Dodaballapur Road, Avalahalli, Yelahanka, Bangalore-560004, Karnataka for the UG Engineering program which was accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 and validity of accreditation is expiring on 30.06.2021.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for a period of 3 years i.e. up to 30-06-2021 and for which the concerned Institutions have submitted Compliance Reports, but, the visits for data verification of the programs are pending because of the current pandemic situation due to Corona virus, the programs will be considered for further accreditation of one year i.e. up to 30-06-2022 after data verification of the programs in NBA on the basis of the submitted Compliance Reports. Based on the same, the Competent Authority in NBA has approved the following accreditation status to the program as given in the Table below:

Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
