With reference to the aforesaid subject, the University has received many requests from UG students who have admitted to 2022 scheme and are not eligible to 7th semester due backlogs of 1st year. A committee was constituted in this regard.

Hence, based recommendations of the Committee and aforesaid approvals, the following is notified:

- 1) The students admitted to 2022 scheme by regular admission are permitted to appear for their 1st year backlog courses during the ensuing Summer Semester Examinations schedule to commence from 15th September, 2025
- 2) Further the interested students, who are migrated to 2022 scheme at 3rd semester level from 2021 and 2018 are also permitted to appear for their 1st year backlog courses during the aforesaid examinations. However, they have to appear for courses in 2022 scheme only. And if they wish appear for the backlog courses in their respective schemes of 1st year, then they have to appear during the examination whenever conducted by the University.

This benefit is extended to: affiliated colleges, autonomous colleges, VTU constituent colleges and VTU departments.

Hence, the Heads of institutions of affiliated colleges, autonomous colleges, VTU constituent colleges and VTU departments are hereby directed bring this to the notice of the concerned students without fail.
