Subject: Additional Credits Registration for NE courses of $1^{\rm st}/2^{\rm nd}/3^{\rm rd}$ semester for the UG students admitted in 2023– Reg.

The students admitted to the UG program in 2023 are given an opportunity to register for the additional credits of 1^{st} / 2^{nd} / 3^{rd} semester not eligible (NE) courses.

1. About the Additional credits registration:

- This provision is provided for not satisfying sessional requirements (NSSR) and not satisfying attendance requirements (NSAR) students. The course/s for which the student does not possess satisfactory attendance and Continuous Internal Evaluation (CIE) score will be designated as "NE". These students are eligible for re-registration for courses marked as "NE". This is provided to help the student in not losing an academic year.
- 1st / 2nd / 3rd semester Not-Eligible students must mandatorily register for additional credits and compulsorily attend all the classes, for all the courses registered and re-earn the CIE and attendance.

2. Rules and Timeline:

- Students are allowed to register for a maximum of 08 credits of 1st/2nd /3rd semester NE courses along with regular courses of 4th semester. The student shall ensure that the total number of credits should not exceed 28 including regular 4th semester and NE courses.
- Applications for the additional credits' registration will be made available in the departments from **17.03.2025**.
- Last Date for the Registration of courses 22.03.2025.
- The class timetable will be prepared for the registered courses only.
