CIRCULAR

Subject: Supplementary Semester Registration Guidelines for B.E. Students Admitted in 2021 – Regarding.

The students admitted to the B.E. program in 2021 are granted with an opportunity to register for the supplementary semester.

1. About the Supplementary Semester:

- The Supplementary/ Fast track semester is provided to assist failed students. The student has to pay a special fee prescribed by the Institution to register for a course in the supplementary semester. The supplementary/Fast track semester is provided to help the student in not losing an academic year. It is optional for a student to make use of supplementary/Fast track semester. Supplementary/Fast track semester is a special semester, and the student cannot demand it as a matter of right.
- Ineligible students must mandatorily register for Fast track semester and compulsorily attend all the Fast track classes, for all the courses registered and re-earn the CIE and attendance.
- Fast Track Semester (only for students with NSSR/ NSAR with 'F' Grades): Registration of courses - Three days Course work - Six weeks from the date of starting of registration Examination- 9 days Declaration of Results: 3 days Total: Eight weeks

2. Eligibility for Supplementary Semester:

• The course/s for which the student does not possess satisfactory attendance and Continuous Internal Evaluation (CIE) score will be designated as "NE". These students are eligible for re-registration for courses marked as "NE" during the supplementary semester.

3. VTU Guidelines:

According to the VTU (Visvesvaraya Technological University) guidelines, undergraduate program students can register for the supplementary semester after the 4th semester for courses from the 1st to the 4th semester. Similarly, for courses from the 5th to the 8th semester, students can register for the supplementary semester after the 8th semester. To be eligible for the supplementary semester, students must have completed the required internships as per Institute/University Regulations and directions. For students opting for a supplementary semester between the 4th and 5th semester, any missed internships shall be completed during the 5th semester. Please note that the supplementary semester is a special offering and not an automatic right for all students.

This supplementary semester is a valuable opportunity for students to strengthen their academic standing and should be considered judiciously.

4. Rules and Timeline:

- During the supplementary semester, students are allowed to register for a maximum of 16 credits.
- Students are promoted to the fourth year (7th semester) on the condition that they must have successfully completed all the courses from the first and second semester.
- Applications for the supplementary course registration will be made available in the Departments from **16th October 2023**.
- Supplementary course registration is set to begin on 16th October 2023, with classes scheduled to commence on October 18, 2023.
- The class timetable will be announced shortly.
