**CIRCULAR**

**Subject:** Submission of Application Form for Photocopy, Challenge valuation and Makeup Examination PG-MBA 3<sup>rd</sup> Semester – 2024 Batch Regular & 2023 batch **Arrears** – Reg.

The students are invited to Submit Application Forms for the Photocopy, Challenge Valuation and Makeup Examination for PG – 2024 batch Regular (3<sup>rd</sup> Semester) & 2023 batch **Arrears** courses of which the examination conducted in July / Aug - 2025, with Provisional Results Declared on **11.03.2026**

**A. Photocopy and Challenge Valuation:**

**1. Photocopy (PC) of Answer Script (Applicable to all Theory Courses):**

The Students shall request for a **Photocopy** of their answer scripts by Applying for the respective courses separately with a fee of **Rs. 400/-** Per Course along with the Application Fee of **Rs. 20/-** Per Candidate (**Applicable to all Theory Courses**).

**2. Challenge Valuation (Applicable to all Theory Courses):**

The Students shall apply for the **Challenge Valuation** of their answer script of the respective courses separately by paying a fee of **Rs. 6000/-** Per course and an application fee of **Rs. 20/-** Per Candidate (**Applicable to all Theory Courses**).

**Note:** If a student is awarded with higher grade in Challenge Valuation, 50% of the fee paid by the student shall be refunded.

**B. Makeup Exam:**

Student can apply for the Make-up Examinations with a fee of **Rs. 2400/-** Per Course along with the Application Fee of **Rs. 20/-** Per Candidate.

**Make-up Examinations for the Grade 'I' :** As per the VTU norms, the make-up examinations facility shall be available to the eligible students who have failed to attend semester end examinations (SEE) of one or more courses in a semester for valid and convincing reasons acceptable to the college, like:

- (i) Illness or accident which disabled him/her from attending SEE.
- (i) A calamity in the family at the time of SEE, which required the student to be away from the college.
- (ii) Any other verifiable exigency

**Make-up Examinations for the Grade 'X':**

- (i) Awarded to a student having high CIE rating ( $\geq 90$ ) in a course but SEE performance observed to be poor, which could result in an overall 'F' grade in the course.


