
46.2.1 Action taken report on the resolutions made in the BOG Meeting No. 45 held on 15.05.2023.

The action taken with respect to the implementation of the Research policy and Students' scholarship policy approved in the BOG meeting No. 45 was noted and appreciated.

<u>SECTION-3</u> <u>SUBJECTS FOR INFORMATION</u>

46.3.1 I) Academic Matters

a) Approval by AICTE and VTU for Engg programs: Dr. Mohan Babu G N, Principal, BMSIT&M informed that utilising the provisions of NBA accreditation of 4 UG programs, BMSIT&M had sought approval from AICTE and VTU to increase the intake of a few existing programs and also start a new program as follows:

The above proposal from the institute has been approved by the ACITE and VTU and the admissions are going on. The effort of the Principal and faculty members were noted and appreciated by the Hon'ble BOG Members.

b) Commencement of I Year Classes: The Principal informed the Hon'ble BOG members that the classes for the newly admitted students would begin on 15.09.2023 as per AICTE and VTU. Furthermore, he informed the members that the students must undergo an Induction program of 11 days and 10 days respectively at the beginning of the 1st and 2nd semesters.

Dr. Dayananda Pai sought information on the status of Admissions, and in reply, the Principal placed on record that already 55% seats have been filled up and the CET and COMED-K admission processes are still going on. Dr. Mohan Babu G N informed the Hon'ble BOG members that 95% of the approved intake was filled up in the previous year, and the same trend is expected to continue for the present academic year as well.

Dr. S K Saidapur enquired about the impact of the Induction program on first-year students and whether the outcomes are measured. Dr. Mohan Babu G N, Principal explained that reports of the daily activity under the induction program are submitted to the principal. Further, students' feedback is also sought for these activities. At the end of the Induction program, competitions are held to assess the level of participation/understanding of the program by students and a consolidated report of the Induction program is sent by the Institute to the VTU and AICTE.

- c) Status of NBA and NABL Accreditation of Civil Engineering: Dr Mohan Babu G N, Principal, informed that the NBA Expert Team had carried out the assessment of Civil Engineering program in July 2023 and the result is awaited. The Principal also placed on record that the Civil Engineering program has applied for NABL accreditation and the Expert Team from NABL is expected to visit BMSIT&M in a fortnight. The Hon'ble BOG Members noted the collective effort of the Institute staff and wished them well.
- d) Honors of VTU Ranks and Gold Medals: The Hon'ble BOG noted the achievements and appreciated the same.

Results of the Semester-end Examination: Dr. Mohan Babu G N, Principal, BMSIT&M presented before the BOG members the results of VTU examinations (3rd and 4th year) and Autonomous (odd semesters of 1st and 2nd years). He also said that the results shown above reflect only the students who have passed in all the subjects. Principal expressed that the examination results of the Mechanical engg department need improvement and the dept staff are working hard for that. Principal explained that the results, especially in the second year, are largely impacted by the lateral entry students who get admitted in the second year. He shared that remedial classes are conducted by faculty members to overcome the problem. Dr. N C Shivaprakash concurred with the principal's views and appreciated the efforts of the Faculty Members.

The Hon'ble BOG members noted that the overall results are very good and congratulated the principal and faculty members for the same.

k) Our Faculty Member as a Qualified Patent Agent: The Principal placed on record that BMSIT&M hosted Indian patent exam and Indian Trademark exam at the institute under the supervision of Patent officials from Chennai and Mumbai. It is a matter of pride for BMSIT&M, as it was one among the only eight examination centers across India.

Further, he shared that Mr. Praveen Kumar T N, Associate Professor, Mechanical Engineering, qualified in the patent exam to become a Qualified Patent Agent. Dr. Unnat Pandit thanked the Management, Principal, and Faculty Members for hosting the Patent Exams. He also opinioned that Faculty Members obtaining patents may be felicitated in recognition of their efforts. The suggestion was noted by the principal.

Dr. Unnat Pandit also informed the BOG members that Accreditation bodies like NAAC and NBA are considering commercialization of patents, as one of the evaluation criteria.

Dr. Mohan Babu G N placed on record, that the institute provides full financial support to faculty members filing for patents, without attaching any conditions. Further, the Principal informed the BOG members that BMSIT&M has tied up with KSCST and is regularly conducting workshops for the faculty members.

BOG members, Dr. N C Shivaprakash, Dr. S K Saidapur, Dr. P P Binu and Dr. Unnat Pandit appreciated the benevolence of the Trustees.

Dr. Dayananda Pai, Life Trustee, BMSET, suggested increasing the capacity of the hostels as well as the academic space.

Dr. Manjunath T N, Dean Career Guidance, presented the placement status. The Hon'ble members of BOG noted the status of placement of graduating students and appreciated the effort of the Principal, Dean CG, placement team, and HODs of the Departments.

Dr. Manjunath T N acknowledged the invaluable help being provided by the Alumni for establishing contacts with HR personnel of various multinationals.
