The Principal welcomed all the members (both internal and external) to the 4th Academic Council meeting.

#### **Academic Council Meeting:**

Dr. Thippeswamy G (Member Secretary, Academic Council, BMSIT&M) presented the agenda of the meeting and proceedings of 3<sup>rd</sup> academic council meeting. The details about human resources, best practices, academic processes, and achievements of students/faculty members were also presented with precise data.



Following are the details of the deliberations made during the meeting on the presentations made:

**Dr. Thippeswamy G. presented the following:**

- The action taken and the status of the suggestions mentioned by the members during the third Academic Council meeting.
- Rotation and changes of Vice-Principal, Deans and HoDs, the addition of intake, a new programme started and the status of faculty recruitment to maintain SFR as 1:20 were discussed.
- The status of Accreditation (NBA) and Ranking (NIRF) for the year 2022-23 is presented.
- Details of the meetings of the Boards of Studies held in the departments were highlighted.
- Some of the important events related to co-curricular, curricular and extra-curricular events of the Institute are presented including Industry- institute interaction (MoU) held with M/s Carl Zeiss, IBM India Private Limited, Gamut Analytics Pvt. Ltd was presented.
- Hackathons are conducted to enhance the coding skill of students of various branches.
- NEP based components such as Open / Value added courses, Project-Based Learning etc.
- Approval of NPTEL policy for faculty members and students was also presented.
- Research policy and grants for faculty members were elaborated.
- Constitution of Anti-Malpractice Committee to handle malpractice cases for CIE and SEE was discussed.
- VTU ranks and gold medals for academic year 2021-22 were highlighted.
- Detailed data of SEE results (Autonomous), Placement and Higher studies for the year 2022-23 were also presented.

**Dr. Hanumantharaju M.C, Controller of Examinations (CoE)** briefed about the constitution and purpose of the Anti-Malpractice Committee, quality of BoE meetings, scrutiny of question papers along with schemes and challenge valuation. Also presented the status of procuring Digital pads for examination which is in process.

#### **D. Sathish Kumar K M, Dean (Academics)**

- Expressed the possibility of setting the Center of Excellence by M/s Carl Zeiss India in the manufacturing of metrology devices.
- Mentioned that an equivalence committee has been formed at the institute level for evaluating cases of readmission of students from affiliated to autonomous status of VTU.
- Conveyed that the institute has framed NPTEL policy to promote honours degrees at the Student's level.
- Informed regarding the number of students awarded with Honors degree from VTU.

#### **Dr. Srinivas Padmanabhuni, Member**

- Suggested to organize separate hackathons for Digital, Circuit and Civil / Mechanical streams.
- Discussed Industry 4.0, the relevance of robotics and coding for any stream of engineering.
- Enquired about placement opportunities and plans for Master of Business Administration (MBA) and discussed the possibility of jobs for graduating students in the Banking Sector and BSF. Placement officer responded with a plan which are being done specifically for MBA students.
- Enquired about the scope of industry-sponsored R&D and travel grants for faculty.
- Advised for Interdisciplinary courses involving Management and Engineering for final-year students.

#### **Dr. Krishnamurthy G.N, Member**

- Enquired about the fees for the open course and whether the faculty members are given remuneration for engaging sessions in the open course. The principal responded with a detailed policy and procedure for conducting Open Value-added Courses.
- Verified the status of the 2021-22 and 2022-23 batch scheme and confirmed whether the subject code is retained in line with the VTU subject code. CoE responded and explained about the subject codes and their retainment.
- Advised to go with IBM and code Tantra for conducting Hackathons for faculty members and students.

- Discussed about the status of Seed Money granted to the faculty members and budget utilization of the Research and Development cell.
- Enquired about the status of the grade that will be maintained after challenge valuation. CoE responded with the details of the policy the institute is following.
- Enquired about the institute's preparedness for Convocation of Master's degree and framing of policy for Endowment Awards. Principal responded the details about the work done in this regard.
- Advised/enquired about another meeting of the Academic Council to be conducted after the 2022 syllabus is given by the VTU.
- Discussed and agreed on answers script viewing and revaluation for CAED, CAMD and Surface Modelling courses as like other theory courses.
- Enquired whether the Honors degree policy is the same as VTU for the autonomous scheme.

### **Subjects for discussion and approval:**

#### **The following matters were deliberated and approved:**

- Distribution of credits for the 2021-22 batch among various semesters.
- CIE and SEE pattern for 2021-22 and 2022-23 schemes.
- Equivalence Committee and its recommendations for the readmitted students.
- Conduction of CAED examination without USN based on oral approval from VTU.
- Approval for providing Answer Script Viewing and revaluation for CAED, CAMD and Surface modelling courses as like any other theory courses.
- Revised gracing policy for the year 2022-2023.
- Course code standardization in line with VTU.
- Reframe/Revise the Institute's Vision and Mission statements due to the MBA programme which has started from 2022-23.
- To introduce specialization in MBA programme with engineering courses.

Other members (HoDs) shared their suggestions and thanked all the external members for their valuable input.
